Re: Knoxville Multi-Family Zoning Poll Results

A new poll from American Strategies shows that Knoxville voters are highly supportive of changing zoning laws to accommodate more types of housing across the city. Almost three-quarters (73 percent) agree with a statement that Knoxville needs more housing options, like duplexes, triplexes, and small apartment complexes (42 percent agree *strongly*). Seventy percent also agree that Knoxville's economy benefits from additional residents, and 61 percent agree that building more housing will help reduce the overall cost of housing in Knoxville.

An overwhelming majority (83 percent) recognize that housing costs in Knoxville are a significant issue, with 59 percent who say costs are a *very big problem* and a further 24 percent who say they are a *fairly big problem*. Eleven percent say costs are a *moderate problem*, while just four percent say that costs are a *slight problem* or *not a problem at all*. A plurality (48 percent) say that housing costs are the most important issue for the Knoxville city government to focus on; crime and public safety follows distantly with 20 percent, with traffic and congestion (12 percent) as the third top concern.

Over two-thirds (69 percent) agree that Knoxville lacks enough housing options. In particular, 83 percent of voters say that there is not enough housing for younger people and those just getting started in their careers, and 80% say the same for people with low incomes. Seventy-one percent also agree there is a lack of housing for people with moderate incomes, and 56 percent say there are too few apartments to rent.

After hearing a brief description of proposed changes to zoning laws in Knoxville, 64 percent favor changes to encourage more multi-family development (36 percent strongly). Thirty-one percent are in opposition (17 percent *strongly*), and four percent are unsure.

Nearly half of voters (47 percent) say that they experience at least *slight* strain in covering their monthly housing payments. This trend is especially pronounced among voters who do not own a home (81 percent), and voters under the age of 50 (61 percent). Eighty-nine percent say that if they had to find another home or apartment in Knoxville today, it would be at least *somewhat* difficult for them to do so.

The poll was conducted between September 18th and 22nd 2023, using a combination of live interviews over the phone, and online interviews completed through SMS-to-online. American Strategies interviewed 404 registered voters in total, yielding a margin of error of +/-4.9 percent.



Plurality say Knoxville is Headed in the Right Direction; **Housing Costs by Far the Top Concern**







Over Two-Thirds Cite a Lack of Housing Diversity in Knoxville



Over Two-Thirds Say Too Little Housing for Low-Income Residents, Younger People





Financial Strain



Ease of Finding Housing in Price Range





Housing Growth and Development Statements




